<b>ROLE SUMMARY</b>
<p>Commercial Tutors work as part of a teaching team delivering classes on the Dance and Musical Theatre courses at Italia Conti across both our degree and diploma programmes at our new campus in Woking. Reporting in to the Head Tutor for Contemporary &amp; Commercial, postholders ensure the curricula are delivered as written and contribute to their continued development.</p> <p>Sessional Tutors work typically work 2 days-per-week or fewer on an hourly-paid basis. Salaried Tutors typically work no fewer than 3 days-per-week (0.6FTE) and would be involved in a broader range of activities as part of the established teaching faculty, including module leadership, auditions, pastoral and administrative duties.</p>

- Supplying marks and feedback to the programme co-ordinator as necessary.
- Contributing to all documentation required through validation or accreditation processes.
- Keeping abreast of current movements in specific areas and ensuring the relevance and contemporaneity of the provision.
- Taking responsibility for own development activity in teaching, practice and safeguarding/welfare.
- Contributing to recruitment, selection and admission processes as necessary, including audition panels.
